Housing Law Center Update

Eviction Rates at a Crisis Level

There is a dire need for counsel to help tenants in private eviction actions. According to the Providence Journal, Providence has nearly 3 times the eviction rate as neighboring Boston. Over 92% of tenants facing evictions do so without the help of counsel. We have focused our attention on these issues by expanding our eviction defense work through the Housing Stability Project. One of our strategic goals is to identify and address the growing eviction crisis which effects Rhode Island's most disenfranchised

****Breaking News**** Champlin Foundation Funds the Purchase of Additional Space

Through a generous grant from the Champlin Foundation, RILS has purchased an additional 6,000 square foot space in our current Hanley Building location. Expanding the physical space of the Housing Law Center enables us to devote more staff to working with Rhode Islanders facing the eviction crisis.

Rhode Island Foundation Invests in the Expansion of the Housing Stability Project

RILS has received a \$100,000 grant from the **Rhode Island Foundation** toward supporting staffing in the Housing Law Center. This support will allow us to devote more resources to private landlord-tenant matters so that this group of vulnerable Rhode Islanders can get the assistance they desperately need (but have been unable to get).

RILS will use this new funding to assist tenants in private landlord-tenant disputes. In an effort to maximize the impact of the Rhode Island Foundation's investment, RILS will conduct community outreach throughout Rhode Island with the goal of educating tenants about their rights and obligations under the law. RILS staff will also provide training to volunteer law students and attorneys, so that more members of the Bar are ultimately empowered to provide representation in these matters.

Steven S. Flores says, *"Approximately 92% of Rhode Islanders being evicted do not have counsel and landlords almost always do. Thanks to the Rhode Island Foundation's investment, we can keep more families in the homes they already have, which is one of the most efficient ways to combat homelessness and the devastating cycle of poverty that so many Rhode Islanders face."*

Additional Funding Still Needed

RILS has the expertise and the space to combat the eviction crisis. But we need more attorneys. With an additional investment of about \$600,000,

Even a delay in eviction proceedings is a benefit to tenants helping to avoid homelessness. It has been said that eviction is not simply a symptom of poverty, but a cause."

Based on filing numbers from the Rhode Island District Court, on average there are over 20 evictions filed in Rhode Island every day. Additional funding for our Housing Law Center will allow RILS to keep more families in their homes.
